

THE PORT BUSKING PERMIT CONDITIONS

The Permit holder(s) Must:

Read and comply with all of the terms and conditions of The Port Busking Permit and any other Legislative requirement(s).

Retain The Port Busking Permit and keep in your possession at all times whilst performing.

Ensure that the busking performance stays within the designated performance space.

If under 15 years of age, must be supervised by a parent/guardian and only perform in daylight hours.

Permit holders must ensure that the performance does not obstruct pedestrian flow.

Be aware that any amplification or percussion must be kept to a reasonable level and not cause a nuisance to surrounding businesses.

The permit holder will be held liable for any loss, damage, expense or claim directly or indirectly arising from the busker's performance.

Be aware that non compliance with permit conditions will result in the permit being revoked. You will be required to cease your performance and vacate the event site.

Comply with the following restrictions as part of the performance.

The Permit holder(s) Must Not:

Perform without a valid permit.

Use any sharp object or other dangerous instrument including knives, swords, and chainsaws.

Use a stock whip or light or use fire or any flammable liquid.

Charge a specific fee for a performance.

Cause damage to surface or use any aerosol containers.

Use a child or any other person not covered by the permit or use any animal in or as part of the performance.

Harangue, argue with, abuse, use abusive language or cause discomfort to the public.

Make physical contact with the public unless it is to apply face paint, a henna tattoo, or similar type of act/performance.

Leave any equipment in a position that may create a hazard to the public.
